ARTICLES OF INCORPORATION
OF

JENNIFER DECKELMAN STUDIO, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I. NAME

The name of the corporation ("Corporation") shall be:

JENNIFER DECKELMAN STUDIO, INC.

The street address of the principal office of the Corporation shall be 927 E. Klosterman Road, Tarpon Springs, Florida 34689 and the mailing address shall be the same.

ARTICLE II. NATURE OF BUSINESS

This Corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

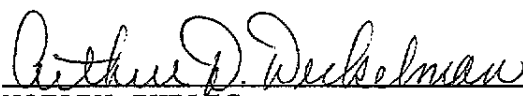
