ARTICLES OF INCORPORATION OF CHASIN CORP.

PREAMBLE

I, the undersigned, do hereby associate myself under the following Articles, for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the Corporation shall be:

CHASIN CORP.

ARTICLE II

PRINCIPAL OFFICE

GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this Corporation is:

(1) Owning, managing, renting and operating real estate investments both within and outside the United States.

CORPORATE POWERS

- (3) No stock in this Corporation shall be sold or transferred other than by operation of law, unless and until the record owner thereof shall have given written notice, by certified mail, to the Corporation at its principal office, setting forth a desire to sell such stock, together with the price, terms and conditions upon which said stock shall be offered for sale. terms and conditions set forth in said notice at any time within thirty (30) days of the corporation's receipt thereof.
