ARTICLE XV. INDEMNIFICATION

The corporation shall indemnify all directors, officers and authorized agents of the corporation who are made a party, or threatened to be made a party, to any litigation or legal proceeding, whether civil or criminal, administrative of investigative, arising from the fact that such person is a director, officer or authorized agent of ten corporation, against all expenses, attorney's fees (including appellate proceedings), judgments, fines and, subject to obtaining the prior written consent of the corporation, amounts paid in settlement as well as costs reasonable incurred in connection with such litigation or proceedings, unless (a) a court of competent jurisdiction finally determines, after all appeals are exhausted or if such appeals are not pursued by the proposed indemnitee, that the proposed indemnitee did not act in good faith or in a manner the proposed indemnitee reasonably believed to be in the best interest of the corporation and, with respect to any criminal action or proceeding, that the proposed indemnitee did not have reasonable cause to believe that his or her conduct was lawful, and (b) such court also determines specifically that indemnification should be denied due to the circumstances giving rise to such proceedings. The termination of any action, suit or proceeding by judgment, order, settlement of conviction or upon a plea of no contest or its equivalent, shall not, of itself, create a presumption that a person seeking indemnification did not act in good faith and in a manner which the person reasonably believed to be in the best interest of the corporation, and with respect to any criminal action or proceeding did not have reasonably cause to believe that his or her conduct was lawful

- B. Advances: All expenses incurred in defending a civil or criminal action, suit or proceeding shall be paid by the corporation in advance of the final disposition of such action, suit or proceeding upon receipt of a written undertaking by or on behalf of the proposed indemnites to repay such amount unless it shall be ultimately determined that such proposed indemnitee is entitled to indemnification pursuant to this Article.
- C. 
