ARTICLE OF INCORPORATION OF

U - SHIP, CORP.

We, the undersigned, hereby associated together for the purpose of becoming a corporation under the Laws of the State of Florida, by and under the provision of the Laws of said State, providing for the information, liabilities, rights, privileges and immunities of a corporation for profit.

ARTICLE 1. NAME AND ADDRESS

The name of the corporation shall be;

U – SHIP, CORP. (Hereinafter referred to as the corporation). It registered office shall be located at 7640 N.W. 25ST Street. Miami, Fl. 33 In the County of Dade, State of Florida.

ARTICLE 2. --NATURE OF BUSINESS ---

Section 1. The general nature of the business and objects and purpose to be transacted, promoted and carried on are to do any and all things hereinafter mentioned, as fully and to the same extent as natural persons might or could, viz.

- a. To carry on business in the United States of North America or any foreign country or countries, to buy, to sell, import, export, lease, sub-lease, hold, procure, transport, manufacture, acquire and deal generally, both wholesale and retail, in goods and services of all type, both as principal and agent, in any part of the world.
