ARTICLE XII - AMENDMENT:



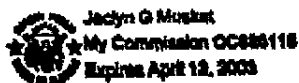


