ARTICLES OF INCORPORATION

OF

ARTICLE 1 - NAME

The name of this corporation is GIFTS ON THE GO, INC.

ARTICLE II - DURATION

The duration of the corporation shall be perpetual and shall commence upon the signing and acknowledging of these Articles.

ATTICLE III - PURPOSE

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT


