This corporation is authorized to issue 100 shares at \$1.00 par value common stock.


ARTICLE 5



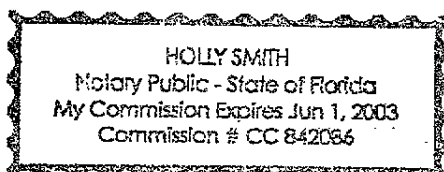


