ARTICLE I. NAME

The name of this corporation shall be Aigean, Inc.

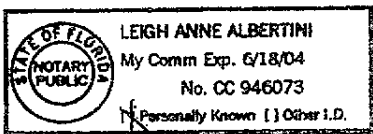
