The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

<u>Name</u>

The name of the corporation is MGM Services, Inc., and its address is: 340 Giralda Avenue, Apt. 817, Coral Gables, Florida 33134.

ARTICLE II

<u>Duration</u>

The duration of the corporation is perpetual.

ARTICLE III

<u>Purpose</u>
