ARTICLES OF INCORFORD

OF

M. SANTOS ENTERPRISE, INC.
(a corporation for profit)

The undersigned, for the purpose of forming a corporation for profit under the provisions of the Business Corporation Act, do hereby adopt the following Articles of Incorporation.

ARTICLE I Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation.

ARTICLE II DURATION
