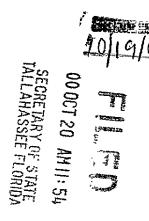

ARTICLES OF INCORPORATION

OF

INTERVEST CONSTRUCTION OF ORLANDO, INC.

A Florida Corporation



ARTICLE 1

NAME AND ADDRESS

The name of the corporation is INTERVEST CONSTRUCTION OF ORLANDO, INC. The address of the corporation is 2359 Beville Road, Daytona Beach, Florida 32119.

ARTICLE 2

DURATION

The duration of the corporation is perpetual. The date and time of commencement shall commence on the date these Articles of Incorporation are executed and acknowledged, except that if they are not filed by the Department of State of Florida within five business days after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

ARTICLE 3

GENERAL PURPOSES

The general purposes for which this corporation is initially organized are to engage in any or all lawful business for which corporations may be incorporated under Florida law.

ARTICLE 4

SHARES

The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares of common voting stock having a par value of \$1.00 per share.

ARTICLE 5

PRINCIPAL OFFICE AND REGISTERED AGENT

ARTICLE 6

DIRECTORS

The number of directors constituting the initial Board of Directors is one (1) and the name and address of each person who is to serve as a member thereof are as follows:
