ARTICLES OF INCORPORATION of ISLAND HOUSE RENTALS & SALES, INC.

These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida General Corporation Act, as particularly set forth in Chapter 607 of the Florida Statutes.

ARTICLE I. NAME

The name of this corporation shall be Island House Rentals & Sales, Inc.

ARTICLE II. PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation shall be at: Island House Rentals & Sales, Inc.

or such other location as time to time determined by the board of directors.

ARTICLE III. DURATION

The corporation shall commence upon the filing of these Articles and shall have perpetual existence thereafter.

ARTICLE IV. PURPOSE

The purpose for which the corporation is organized is the transaction of rental and sales programs for the Island House Condominium located in the County of St. Johns, St. Augustine, Florida and any and all other lawful business for which a corporation may be incorporated under the Florida General Corporation Act, as the same may from time to time be amended.

ARTICLE V. SHARES

The aggregate number of shares of capital stock which this corporation shall have authority to issue shall be 100 shares of common stock.

ARTICLE VI.

ARTICLE VII. PREEMPTIVE RIGHTS

Directors of the corporation have the power to approve shareholders and remaining holders (if any) of the initial stock offering and reserve the right of first refusal on all stock offers, sales or exchanges. Stock offers, exchanges and sales must be approved by a majority of the directors at a duly called board meeting.

ARTICLE VIII. DIRECTORS

The business and the affairs of this corporation shall be managed by a Board of Directors, which shall be elected by the shareholders and serve as provided in the Bylaws. The number of the members of the Board of Directors may either be increased or decreased from time to time as prescribed in the Bylaws.
