ARTICLES OF INCORPORATION
(GENERAL)

ARTICLE I
CORPORATE NAME

The name of the Corporation is M.A. PAINTER & CARPENTER CORP.

ARTICLE II
PURPOSE

The purpose of the Corporation is to engage in any lawful act or activity for which a corporation may be organized under the Painter & Carpenter Law of the State of Florida other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the State of Florida Corporations Code.

ARTICLE III
