WE, the undersigned hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the said State of Florida.

ARTICLE I.

The name of the corporation shall be:
Club Hell, Inc.

ARTICLE II.

The general nature of the business and objects and purposes proposed to be transacted and carried on, are to do any and all activities or businesses permitted under the laws of the United States and of this State, as fully and to the same extent as natural persons might or could do.

To carry on the business of operating teen social and dance clubs, promote and operate all types of social functions, produce and operate all types of concerts, etc., and to do all other matters relating to the above.

ARTICLE III.

CAPITAL STOCK




