ARTICLES OF REVOCATION OF DISSOLUTION

Pursuant to the provisions of Section 607.1404, Fla.Stat., ENO CONSTRUCTION Inc adopts these Articles of Revocation of Dissolution:

First: The name of this corporation is ENO CONSTRUCTION Inc.

Second: The effective date of the dissolution which is being revoked is March 1st 2002.

Third: Pursuant to 607.1404, Fla.Stat., revocation of dissolution was authorized and approved by unanimous vote of the shareholders of the Corporation on March 1st 2002. The number of votes cast in favor of the Dissolution was sufficient for approval.

Fourth: The Articles of Dissolution were authorized by a Written Consent of the Majority Vote of the shareholders on March 1st 2002. Thus this revocation by a unanimous vote of the shareholders at a special meeting of the shareholders is authorized in the same manner as the dissolution.
