ARTICLE I - NAME, PRINCIPAL ADDRESS AND MAILING ADDRESS

The name of the Corporation shall be **UV CLEAR SYSTEMS, INC.** The principal and mailing address of the corporation shall be 2442 23rd Street North, St. Petersburg, FL 33713.

ARTICLE II - CAPITAL STOCK






