**ARTICLES OF INCORPORATION**  
**OF**

The undersigned incorporator, for the purpose of forming a corporation pursuant to the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE 1.**  
**NAME.**

The name of the corporation is **CORTEZ STUDIO, INC.**

**ARTICLE 2.**




