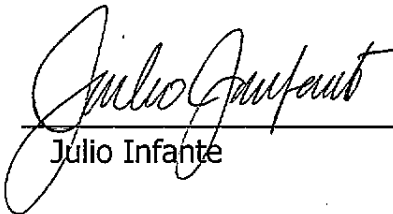

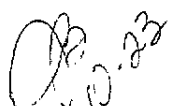

AMENDMENT

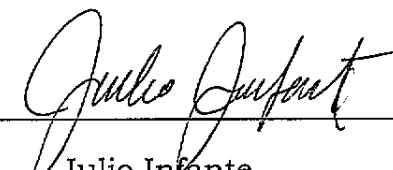
