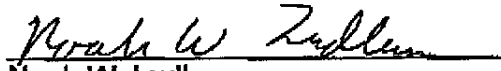
ARTICLE IX

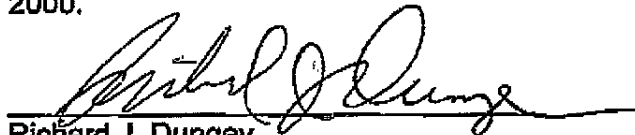
