

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

The name of this corporation is A QUALITY PLUMBING SERVICE, INC.

ARTICLE II.

The main location where the company shall conduct its business is 5896 Ratliff Road, Callahan, Florida 32011.

ARTICLE III.

The duration of the corporation shall be perpetual.

ARTICLE IV.

The purpose of the corporation shall be to provide plumbing services both to residences and commercial businesses and for any other lawful purpose for which corporations for profit are incorporated under the laws of the State of Florida.

ARTICLE V.

The method of election of directors shall be as stated in the corporate by-laws.


