ARTICLES OF INCORPORATION OF

INTERNATIONAL MINING COMPANY OF AMERICA, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, herby acts as an incorporator in adopting and filing the following articles of incorporation for the purposes of organizing a business corporation.

ARTICLE I.

The name of the Corporation ("Corporation") is:
