ARTICLES OF INCORPORATION

The Undersigned, acting as incorporator of a corporation, under the Florida General Corporation Act, adopts the following Articles of Incorporation of such Corporation.

ARTICLE I

The name of the Corporation is SEAFOOD & MORE, INC.

The name and address of the incorporator (s) (is) (are) LOIDA A.LEANDRY 1215 LISBON STREET CORAL GABLES, FL 33134.


ARTICLE IX
