ARTICLE I - NAME AND ADDRESS

The name of this corporation is **DIAMOND REPLAYS, INC.** (the "Corporation").

The power to alter, amend or repeal the Bylaws shall be vested in each of the Board of Directors and the shareholders of the Corporation.


ARTICLE VIII - INDEMNIFICATION


