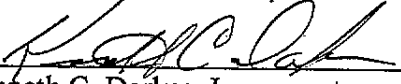

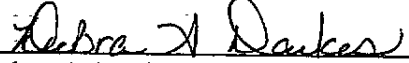
Pursuant to Section 607.0123 of the Florida Statutes, the effective date of this document shall be November 1, 2000.
