ARTICLES OF INCORPORATION

OF

LISTEM USA, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Listem USA, Inc.

ARTICLE II

The purposes for which the Corporation is formed are to manufacture, import and export various medical equipment, and to engage in any other lawful purpose and business.

ARTICLE III

The street address of the principal office of the corporation is 4020 NW 60th Avenue, Gainesville, Florida 32653.

ARTICLE IV

The maximum number of shares this corporation is authorized to issue is 1,000,000 with \$1.00 par value, all of which shall be common shares.
