

ARTICLE I: CORPORATE NAME.

The name of this corporation shall be **TRAJANUS, INC.**

ARTICLE VII: PURPOSE.


This corporation is being organized to enter any lawful business purpose within the State of Florida and the United States of America.

ARTICLE IX: ARTICLES OF INCORPORATION ADDENDAS.




