ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following articles of incorporation: ...

ARTICLE ONE. NAME

The name of the corporation is ADVANCE DEALER SERVICES, INC.
