

**ARTICLES OF INCORPORATION  
OF  
LAW FIRM AND LEGAL CLINIC OF  
BROWN & BROWN, P.A.**

The undersigned natural person, acting as incorporator of a corporation under the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation for such Corporation.

**ARTICLE I  
CORPORATE NAME**

The name of the Corporation is Law Firm and Legal Clinic of Brown & Brown, P.A.

**ARTICLE II  
PRINCIPAL OFFICE**




