ARTICLES OF INCORPORATION
OF
WISHES AND DREAMS - A DESIGN ENTERPRISE, INC.

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

Article I - Name

The name of this Corporation is WISHES AND DREAMS - A DESIGN ENTERPRISE, INC. The principal place of business of this Corporation shall be 5414 Fulmar Drive, Tampa, Florida, 33625, or such other place as may be designated by the Board of Directors.

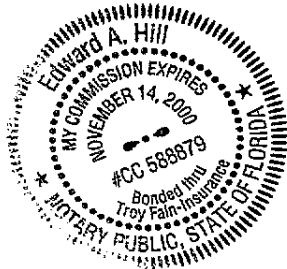
