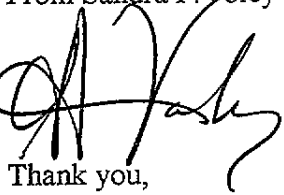

**ARTICLE OF INCORPORATION**  
**OF**  
**MJJG TRADING CORP OF MIAMI INC.**

The undersigned, acting as incorporator of this corporation under the provisions of Chapter 607 of the Florida Statutes, as amended, adopt the following Articles of Incorporation:

**ARTICLE I: NAME OF THE CORPORATION**

The name of the corporation is **MJJG TRADING CORP OF MIAMI INC**, herein after referred to as "corporation"

**ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS**

**ARTICLE III: DURATION OF THE CORPORATION**

The period of duration of the corporation shall be perpetual unless dissolved according to law.

**ARTICLE V: AUTHORIZE SHARES**

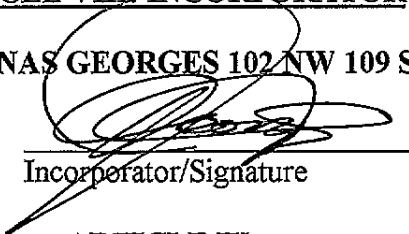
