

The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a professional service corporation in accordance with the laws of the State of Florida.

ARTICLE 1 NAME

The name of this corporation shall be: Juan C. Vila, M.D., P.A.

ARTICLE 2 PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE 3 CAPITAL STOCK

- 1. <u>Authorized Capitalization</u>. The total number of shares of capital stock authorized to be issued by this Corporation shall be 100,000 shares of common stock, par value \$.01 per share (the "Common Stock").

ARTICLE 4 REGISTERED OFFICE AND REGISTERED AGENT

The initial registered office of this corporation shall be located at 3890 Tampa Road, Suite 407, Palm Harbor, Florida 34684 and the initial registered agent of this corporation at such office shall be Juan C. Vila, M.D. This corporation shall have the right to change such registered agent and such registered office from time to time, as provided by law.

ARTICLE 5 BOARD OF DIRECTORS

ARTICLE 8 PURPOSES AND DURATION

The general purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Business Corporation Act of the State of Florida, and any amendments thereto, and, specifically, the practice of medicine as a professional association under Chapter 621, Florida Statutes. In connection therewith, this corporation shall have and may exercise any and all powers conferred from time to time by law upon corporations formed under such Act. This corporation shall have perpetual existence.

ARTICLE 9 RENDITION OF PROFESSIONAL SERVICES

The corporation shall render the professional services described in Article 8 only through its agents, officers, directors, employees and representatives who are duly licensed or otherwise legally authorized in the State of Florida to practice medicine or provide the medical services requested. The term "agents," "officers," "employees," and "representatives" shall not include clerks, secretaries, bookkeepers, technicians, and other assistants who are not usually and ordinarily considered by custom and practice to be rendering professional services to the public for which a license or other legal authorization is required.

ARTICLE 10 BYLAWS

The power to adopt the bylaws of this corporation, to alter, amend or repeal the bylaws, or to adopt new bylaws, shall be vested in the Board of Directors of this corporation.

ARTICLE 11 AMENDMENT OF ARTICLES OF INCORPORATION

This corporation reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Incorporation in the manner now or hereafter prescribed by statute, and all rights conferred upon the stockholders berein are subject to this reservation.

ARTICLE 12 AFFILIATED TRANSACTIONS

The provisions of Section 607.0901, Florida Statutes, relating to affiliated transactions, shall be inapplicable to this corporation.
