CERTIFICATE OF INCORPORATION

OF

WE, THE UNDERSIGNED, HEREBY ASSOCIATE OURSELVES TOGETHER FOR THE PURPOSE OF FORMING A PROFESSIONAL SERVICE CORPORATION FOR PROFIT UNDER THE PROVISIONS OF SECTION 621, FLORIDA PROFESSIONAL SERVICES CORPORATION ACT, OF THE FLORIDA STATUTES, DOES HEREBY ADOPT THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE I

THE NAME OF THIS CORPORATION SHALL BE:

ARTICLE II

THE GENERAL NATURE AND PURPOSES OF BUSINESS TO BE TRANSACTED, PROMOTED AND CARRIED ON BY THE CORPORATION ARE AS FOLLOWS:

- A. TO ENGAGE IN EVERY ASPECT OF A REALTOR AND ALL MATTERS CONCERNING THE SALE, RENTAL AND MANAGEMENT OF REAL OR PERSONAL PROPERTY AND BUSINESS OPPORTUNITIES.

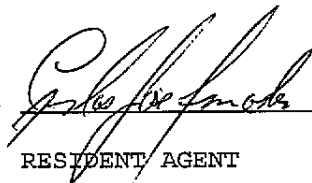
