ARTICLES OF INCORPORATION

THE UNDERSIGNED subscriber (s) to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

THE NAME of this Corporation is: NELSON PRODUCE INC.

ARTICLE II. NATURE

THE GENERAL NATURE of the business to be transacted by this Corporation shall be: Wholesale, retail and export of produce.

- A. To engage in every aspect and phase of the business of operating a produce wholesale, retail and export business.
