Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is **LINK PROPERTIES, INC.**
2. The Articles of Incorporation were filed on October 25, 2000.
3. The Articles of Incorporation are hereby amended as follows:

ARTICLE ONE

The name of the corporation is **LINK PROPERTIES, INC.**

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purpose for which the corporation is organized is to engage in the real estate business; and to purchase, lease, or otherwise acquire such grounds or buildings as this corporation may need in carrying on its business; and to transact any other lawful business or business for which corporations may be incorporated under the laws of the State of Florida.

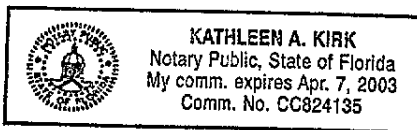
