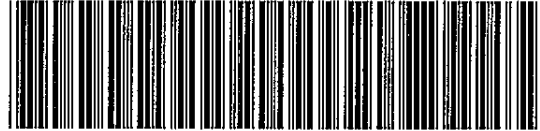

Pursuant to the provisions of Section 607.1003 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the Corporation is ABELL GARCIA ARCHITECTS, P.A.

2. The following amendment to the Articles of Incorporation was adopted by the Shareholders of the Corporation on the 15th day of May, 2003 in the manner prescribed by the Florida Business Corporation Act:

Article I, titled "Name," is hereby amended to read as follows:

Article I

Name

The name of the Corporation is ABELL GARCIA ARCHITECT, P.A.

3. The shares of the Corporation issued and outstanding at the time of adoption was One hundred (100) shares and the number of shares entitled to vote thereon was One hundred (200).

4. The number of shares voted in favor of such amendment was One hundred (100) shares and the number of shares voted against such amendment was zero (0).

5. The number of votes cast by the Shareholders of the

Corporation in favor of the foregoing Amendment to the Articles of Incorporation was sufficient for approval.

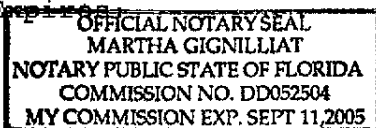
