ARTICLE I - NAME AND ADDRESS

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

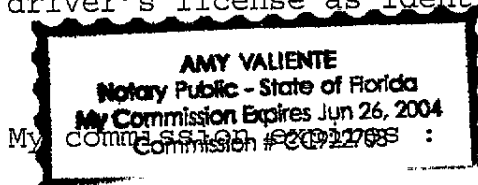
