ARTICLES OF INCORPORATION

OF

The undersigned does hereby associate themselves for the purpose of forming and \$\omega\$. becoming a corporation for profit under the laws of the State of Florida, and does hereby certify that they have become such corporation under and pursuant to the following Articles of Incorporation.

I

The general character of the business to be transacted by said corporation shall be, and is as follows:

- A. To engage in any activity of business permitted under the laws of the United States and of the State of Florida.
