ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of this corporation is **TECHSTON, INC.** The principal place of business is: 125 West Romana Street, Suite 224, Pensacola, Florida 32501.



These Articles of Incorporation may be amended in the manner provided by law.

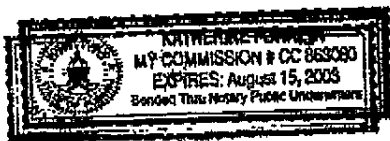
