ARTICLES OF INCORPORATION

OF

CASH MASONRY, INC.

ARTICLE I

NAME OF BUSINESS

The name of the corporation shall be: CASH MASONRY, INC.

ARTICLE II

NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the laws of the United States and this state.

ARTICLE III

STOCK OF CORPORATION

The corporation is authorized to issue and have outstanding at any time 100 (ONE HUNDRED) shares. Each share of common stock shall have one (1) vote.

The initial stockholders of this corporation shall have preemptive rights with respect to all stock issued by the corporation, including stock authorized but not issued and held in the corporate treasury. The stockholders of this corporation shall not have redemptive rights with respect to the stock of this corporation.

Authorized capital stock may be paid for in cash, services, or property, at a just value to be fixed by the governing stockholders and officers of the corporation.

ARTICLE IV

INITIAL CAPITAL

The initial capital of the corporation shall be \$500.00 (FIVE HUNDRED DOLLARS).

ARTICLE V

TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE VI

ADDRESS

The governing stockholders or officers may, from time to time, designate such other address and place for the principal place or business of this corporation as they may see fit, with the

**ARTICLE VII**  
**RESIDENT AGENT**

The initial resident agent and her address for this corporation is: Traci B. Cash, 271 Chelsea Drive, Crawfordville, FL 32327.

**ARTICLE VIII**  
**MANAGEMENT**

The business of the corporation shall be managed by the stockholder of the corporation, including, without limitation, the authority to adopt and amend by-laws, rather than by a Board of directors. It shall be necessary for the approval of ratification of any corporation action that the holders of at least fifty-one percent (51%) of the outstanding stock of the corporation concur therein.

**ARTICLE IX**

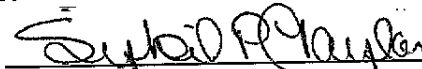
