ARTICLES OF INCORPORATION

OF

The undersigned, being natural persons of legal age, do hereby declare to form a corporation under the laws of the State of Florida, and do hereby adopt these following articles of incorporation.

ARTICLE I

The name of the corporation shall be Sri Ram Int'l., Inc.

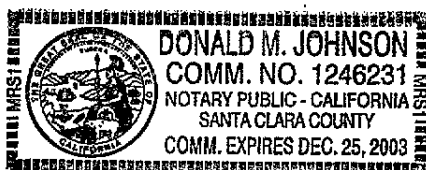
