The undersigned subscribers to these Articles of Incorporation, competent to contract, hereby form a professional corporation for profit under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation is **CLARK B. MILLER CITRUS, INC.** The mailing address is: 135 Avenue W NE, Winter Haven, FL 33881.

**ARTICLE II - PURPOSE**

The corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE III - CAPITAL STOCK**

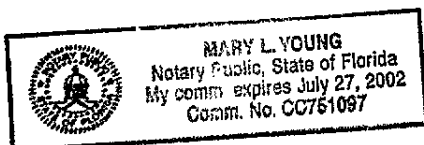

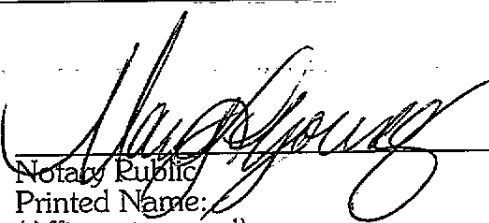

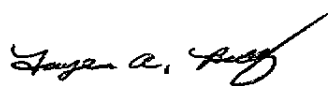
