The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME. The name of this corporation is TOTALLY RAPID APPLICATION DEVELOPMENT INC.

ARTICLE II. NATURE OF BUSINESS. This corporation may engage in any activity of business permitted under the laws of the United States and the State of Florida.

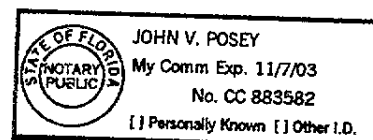


