DURATION

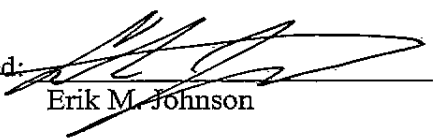
This corporation is to exist perpetually.

INDEMNIFICATION

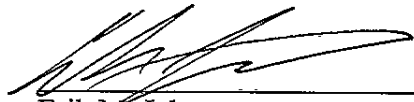

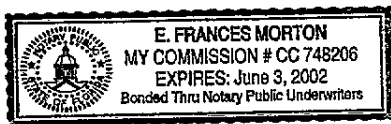

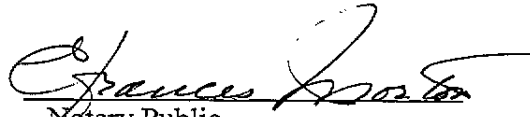
