<u>ARTICLE I - NAME</u>

The name of the corporation is Feeding Frenzy, Inc. (hereinafter called the "Corporation").

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for corporations organized under the Florida Business Corporation Act of the State of Florida.
