ARTICLES OF INCORPORATION
OF

ARRINGTON MORTGAGE SERVICES, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is ARRINGTON MORTGAGE SERVICES, INC.

ARTICLE II

The existence of the Corporation shall begin on November 1, 2000. and shall be perpetual.

ARTICLE III

Purposes. The purposes for which this corporation is organized are as follows: To engage in the business of conducting a mortgage brokerage business and to conduct any lawful business.

ARTICLE IV

The street address of the principal office of the Corporation is 12947 Walsingham Road, Largo, FL 33774.

ARTICLE V

The maximum number of shares this Corporation is authorized to issue is 1000, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE VI

The initial board of directors shall consist of 2 members.

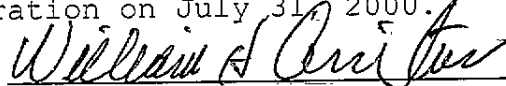
