ARTICLES OF INCORPORATION of Kniseley Inspection Services, Inc.

The undersigned hereby adopt the following Articles of Incorporation for purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I Corporate Name

The name of this corporation is Kniseley Inspection Services, Inc. (which is hereinafter called the "Corporation").

ARTICLE II Commencement and Duration

The Corporation is to commence its corporate existence on the date of subscription and acknowledgment of these Articles of Incorporation and shall exist perpetually thereafter until dissolved according to law. If these Articles are not received by the Secretary of State's office within the time required by law, then existence shall commence on the date of filing with the Secretary of State's office.

ARTICLE III Purpose

The general nature of the business to be transacted by the Corporation and the objects and purposes of this Corporation shall be to offer to the general public residential inspection services; to wit, to inspect, examine, investigate and evaluate the condition of residential buildings, whether single family home, condominium, cooperative apartments, timeshare apartments, etc. and to render an opinion as to the general condition of the structure, its interior and exterior finishes, the adequacy of its mechanical and electrical systems, including heating, ventilating and air conditioning, plumbing, appliances, etc.; and to identify any repairs required to 1) put mechanical and electrical systems and appliances in normal working order and 2) make the residential structure comply with acceptable local standards of use and habitability.
