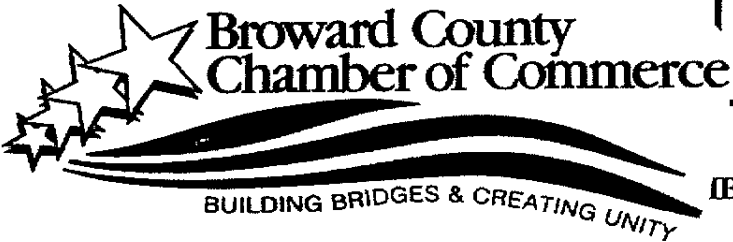

ARTICLE I: NAME

THE NAME OF THE CORPORATION IS BEST BUSINESS COUNCIL, INC THE MAILING ADDRESS OF THE CORPORATION IS 3045 NORTH FEDERAL HWY SUITE 60, FORT LAUDERDALE, FL 33306.

ARTICLE II: DURATION

THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE.

ARTICLE III: PURPOSE

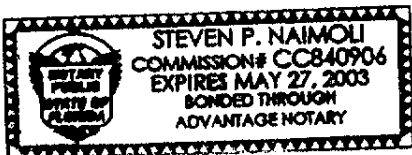
