ARTICLES OF INCORPORATION

OF

I, the undersigned subscriber to these Articles of Incorporation, person competent to contract, hereby forms a corporation under the laws of of Florida.

ARTICLE I

The name of this corporation shall be:

SOUTH FLORIDA SHAVINGS, INC.

ARTICLE II

The general nature of the business and the object and purposes to be transacted and carried on are to do any and all of the things herein mentioned, as fully and to do the same to the same extent as natural persons might or could do.

ARTICLE III

The maximum number of shares of stock of this corporation authorized to be outstanding at any one time shall be 1000 shares of common stock of the par value of $\frac{\$1.00}{100}$ each. The consideration to be paid for each share shall be fixed by the Board of directors.
