**ARTICLES OF INCORPORATION
OF
GULF ATLANTIC TREES, INC.**

The undersigned subscriber hereby files these Articles of Incorporation with the Secretary of State of the State of Florida, for the purpose of forming a corporation for profit in accordance with the Florida Business Corporation Act, Chapter 607 of the Florida Statutes.

**ARTICLE I
NAME AND MAILING ADDRESS OF CORPORATION**

The name of this corporation is Gulf Atlantic Trees, Inc. (the "Corporation"). The physical address of the Corporation is 10415 U.S. Highway 41 North, Palmetto, Florida 34221. The mailing address of the Corporation is P.O. Box 1663, Brandon, Florida 33519.

**ARTICLE II
CAPITAL STOCK**

The Corporation is authorized to issue 10,000 shares of \$.01 par value common stock.

**ARTICLE III
CORPORATE EXISTENCE AND DURATION**

The period of duration of the Corporation shall be perpetual commencing on October 23, 2000.

**ARTICLE IV
CORPORATE PURPOSE**


