ARTICLES OF INCORPORATION

OF

The undersigned, acting as the incorporator of ROBISON GROUP, INC. a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

ARTICLE I – NAME

The name of the Corporation is ROBISON GROUP, INC. The mailing address of the Corporation shall be 1491 Summerland Avenue, Winter Park, Florida 32789.

ARTICLE II - CORPORATE EXISTENCE

The Corporation will exist commencing on the date of filing these Articles of Incorporation with the Florida Department of State.

ARTICLE III – DURATION

The Corporation shall exist perpetually.

ARTICLE IV – PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.
